You are permitted to use the font files for:

- up to 3 desktop workstations
- up to 10.000 unique web visitors per month

End User License Agreement

This is a Multi-Use End User License Agreement – 'Licence'. It is a legally binding contract between 'You' – The Customer and Kostas Bartsokas Ltd – 'Kostas Bartsokas.' By purchasing a License and using the Font from Kostas Bartsokas, You agree that You have fully read, understood and agreed to the terms and conditions of this Licence.

This License grants You a non-exclusive and non-transferable license to use the Font. If You do not agree to the terms and conditions of this Licence, You are not authorised to use any Font from Kostas Bartsokas. You are purchasing a License for usage only, not ownership of the Font.

For the purpose of this licence "Font" is a font software and it is defined as the sum of the designs as well as all additional data and information included in the piece of software, including future updated versions.

General Terms of Licence

Kostas Bartsokas trusts You respect the practice of typographic design. Kostas Bartsokas believes You will respect the vision of empowering the whole industry with affordable typography and will order a License for the correct number of users.

Confidentiality: You agree to treat the Font as confidential information. Except otherwise permitted in this Licence, You are not permitted to copy, reproduce, transfer, sell, license, lend, file share, lease, sub-license or distribute any Font downloaded from Kostas Bartsokas.

Modifications: You are allowed to convert text to outlines. You agree not to edit, modify, reformat, translate, hack or otherwise discover the Font working files, unless it is done solely for Your personal purpose and You do not distribute the modified version. You agree not to alter the copyright notices as contained in the Font code. Any manipulation, violation of use, or Font pirating activity will result in legal action and prosecution. You agree to not recreate or base your own font on Kostas Bartsokas Font character designs. You are not permitted to convert the format of the Font or edit the working file of the Font.

Limitations: The Font can only be used for the maximum number of desktop computer installations and monthly web visitors as defined by this Licence. Each person who uses the Font must have their own License purchased. You are not permitted to use and/or share a License and the Font between users or third parties. If you want to licence multiple users, use the Font in ways not identified and covered by this Licence or for uses that exceed the specified you must contact us and purchase a custom upgrade.

Other Restrictions: The use of Font in racist material, anti-gay material, or malicious or hate activity is not permitted.

Credit: You are more than welcome to credit the font and the designer.

Desktop License Terms

You are allowed to use the Font in up to three workstations owned by a single person or company/organisation at one (1) single geographical location. If You require a License for more than three (3) workstation then please contact us and purchase a custom upgrade.

Third Parties and Service Bureaus: If necessary, you are permitted to supply Font to a printer or a service company for printing or manufacturing/printing of physical material without needing an additional license. You are responsible to ensure the Font is not retained by the third party after your service is complete.

Backup: You may make one copy of the Font for back-up purposes only. We request that you store this in a secure location on an offline hard

drive, disc or in a secure cloud storage facility.

Web License Terms

You are allowed to link the Font to Websites using the @font-face selector in CSS files. The License permits the use of web Font software on any website owned or controlled by You or your subsidiaries or affiliates. Each website must receive a maximum of ten thousand (10.000) unique visitors per month. If You require a License for traffic larger than the specified then please contact us and purchase a custom upgrade.

Font Format: Web Font software is supplied in the following formats: SVG, WOFF, WOFF2, EOT. You are responsible for hosting the software and correctly referring to them with code that You create/manage. You may not link to the full, CFF OpenType or TrueType font designed for desktop installation.

Hosting: You are allowed to host the Font on your website's server or on a CDN (content delivery network). You are expected to make all possible efforts to prevent unlicensed use of the Font by others. You are not allowed to share the font on public webfont-hosting services or any other way that allows unauthorised use.

Guarantee, Warranty, Responsibility and Refunds
